## Purpose

1. Education New Zealand (ENZ) requests that you forward its *Statement of Intent 2019-2023 (Sol)* and *Statement of Performance Expectations 2019-2020 (SPE)* to the Office of the Clerk for presentation to the House of Representatives. *The documents are withheld under s18(d) of the OIA. ## Background

2. On Thursday 27 June 2019, ENZ published the Sol and SPE on its website. Publishing the documents ensured that ENZ met the statutory deadline in the Crown Entities Act 2004 of publishing the Sol and SPE by 1 July 2019.
3. Section 149 of the Crown Entities Act requires the responsible Minister to present the Sol and SPE to the House of Representatives either before or at the same time as ENZ's *Annual Report 2018-2019* is tabled in November 2019. ENZ requests that its Sol and SPE are tabled in the House of Representatives by Thursday 31 October 2019.
4. Instructions from the Office of the Clerk for parliamentary papers require crown entities to forward two printed copies of the documents to be tabled to the responsible Minister. Two copies each of the Sol and SPE are attached to this briefing.
5. The Office of the Clerk requires 30 printed copies and PDFs of the papers that are being presented. ENZ has provided PDFs and 30 printed copies of the Sol and SPE to your office.
