Purpose

1. Education New Zealand's (ENZ's) draft Statement of Intent 2018-2022 (SoI) and Statement of Performance Expectations 2018-2019 (SPE) are attached for your review documents have and feedback

The draft been withheld under s9(2)(f)(iv).

2. Under the Crown Entities Act 2004 (the Act), the minister responsible for a crown entity is requested to provide feedback to the crown entity within 15 working days of receiving the draft Sol and SPE, but is not required to approve them.

Background

- 3. The Sol and SPE reflect the ENZ Board's consideration of strategic priorities in February 2018 in view of the draft New Zealand International Education Strategy and the Government's priorities. The Sol and SPE also reflect ENZ's discussions with our monitoring agencies, the Ministry of Education and Ministry of Business, Innovation and Employment.
- 4. The statistical information contained in this draft of the SoI and SPE is based on the January to August 2017 international student enrolment data, which is the most up-todate data publicly released. In the final version of the SoI and SPE, ENZ intends to use 2017 full year enrolment data, which will be provided to you in May 2018.

Statement of Intent 2018-2022

- 5. Under the Act, ENZ is required to publish an Sol at least once in every three-year period. The Sol is intended to cover a four-year period and contains our medium-term intentions, including:
 - the nature and scope of ENZ's functions and intended operations
 - ENZ's outcome framework and impact measures
 - the activities ENZ will undertake over the period covered by the Sol, including our organisational health and capability.

Statement of Performance Expectations 2018-2019

- The SPE must include:
 - ENZ's statement of forecast service performance, i.e. forecast revenue and expenditure and performance measures for each of ENZ's three appropriations
 - ENZ's prospective financial statements.
- 7. Following discussions with ENZ's leadership team and Board, existing performance measures were reviewed to ensure they best reflect ENZ's activities and priorities. This has resulted in the following changes for 2018-2019:
 - performance measures being retained from 2017/18

- new performance measures
- performance measures from 2017/18 being removed Withheld under s9(2)(f)(iv)
- 8. performance measures from 2017/18 have been changed to activity measures for 2018/19, and additional activity measure added. Withheld under s9(2)(f)(iv)



9. Details of the new and amended performance measures are shown in Appendix One.

Link to ENZ's business plan 2018-2019

10. In conjunction with the SoI and SPE, ENZ is also developing a business plan that talks in more detail about the specific activities ENZ will deliver in 2018-2019. ENZ Board Chair Charles Finny and Chief Executive Grant McPherson discussed ENZ's strategic priorities with you on Tuesday 17 April 2018.

Timeline

- 11. ENZ's Board has provided feedback on earlier drafts of the SoI and SPE. ENZ would like to receive your feedback by Monday 21 May 2018.
- 12. Following the incorporation of your feedback, the Sol and the SPE will be sent to the Board for approval at its meeting on Thursday 7 June 2018.
- 13. On 30 June 2018, the SoI and SPE will be published on ENZ's website to meet the statutory deadline of 1 July which is specified in the Act.
- 14. ENZ will then provide you with copies of the Sol and SPE so they can be tabled in Parliament.

Proactive release

15. ENZ intends to proactively release this briefing as per your expectation that information be released as soon as possible. Any information which may need to be withheld will be done so in line with the provisions of the Official Information Act 1982.
